








# Illés Holding organigram



# I. Freight rail transport

## MMV - Magyar Magánvasút Zrt

The company started active operations on the railway transportation market on May 1st, 2004. Basically, freight rail transport is targeted at the directional mass freight segment, but the company is also constantly adapting to the new market requirements. Significant results have also been achieved in the transport of extraordinary consignments and hazardous materials. Freight rail transport is carried out with the company's own locomotive crew, own and leased vehicles, and their equipment pool is constantly being expanded.

In Hungary MMV is the 3rd biggest railway cargo company.

# II. Road haulage


